2019-2020 SPRING SEMESTER APPLICATION PRINCIPLES

With the press release issued by YOK in line with the measures for the new Coronavirus outbreak As of March 23, 2020, education and training are not interrupted and in practice, the idea of unity Distance Education has started in Sakarya university. Practices taken by Sakarya University Institutes in line with the precautionary measures are as follows:

- All students enrolled in our graduate programs at the course stage 23 March 2020. Theoretical postgraduate courses have been started with Distance Education since 23 March 2020.
- Final exam of all our graduate programs (with thesis / without thesis / distance / doctorate) and without thesis. The necessary announcement about the Undergraduate Project Course will be made by our Rectorate.
- In Specialization and Seminar courses, students can report, present, etc. .consultant of work outcomes they will forward to faculty members for evaluation in the e-mail environment.
- None of the documents that can be obtained through e-government will be handed over by our Institutes. Transmission of other document requests to the e-mail addresses of the institutes. In the event of the requested documents will be issued and will sent via e-mail.
- Conducting Thesis Suggestion and Follow-up exams no later than six months after the Doctoral Proficiency Exam. If the necessary thesis proposals and follow-up exams are not made, they will not fail. The periods (within six months at the latest) will be operated after June 1, 2020.
- Demand of the students who want to take the Thesis Suggestion and Thesis Follow-Up Exams within the time and with the approval of the advisor, the exam can be done online. Will take the thesis proposal exam fifteen days before the student report via e-mail to thesis monitoring committee members, thesis monitoring students who will take the exam must send a month ago. Consultant teaching member shall notify the date and time of the exams to the relevant institute's electronic mail and will ensure that it is coordinated. Members of the Thesis Monitoring Committee will made evaulations, after each member completes the gives attached form separately, they will sent to e-mail adress of instutue. The thesis monitoring report submitted by the student to the thesis committee members the institute must send to the e-mail address.
- Doctorate Proficiency / Master Thesis Defense and Doctoral Thesis Defense exams 1 June 2020 will be made after.
- Deadline for thesis graduate students whose legal period will expire as of Spring Semester. It was determined as June 01 August 14, 2020. Students with legal duration can submit their thesis submissions. They can do it as of June 1, 2020.
- Graduate students working in the laboratories have been stopped from entering the laboratories.
 Only academic and administrative staff are allowed to enter the laboratories for their mandatory work.

The above-mentioned decisions were made by the Higher Education Institution (YOK) on 26.03.2020.taken on behalf of the health of students and faculty upon a press release is covered by the measures.
